HOW TO USE THE RECYCLE RIGHT LOGO

LOGO SPECIFICATIONS

The official typeface for the Recycle Right branding is Futura Bold. It is positioned on the right and centralised within 1x height of the recycle identifier icon, while the tagline 'Care for our environment' is tagged to the logo lock-up. The logo must not be redrawn or recreated in any way. Always use the master files provided.



LOGO COLOUR PALETTE

The Recycle Right logo consists of blue, green and black colours. This is to be applied on a white or light coloured background.

The Recycle Right logo in full colour is preferred as a primary application. The black and white and reverse white variations should be used only when using the full coloured logo is not possible.

HOW TO USE THE RECYCLE RIGHT LOGO

LOGO VARIATIONS

To maintain consistency across all mediums, the master Recycle Right logo format is preferred as a primary application. If it's not possible to use the master logo due to size of medium, you may use the horizontal or stacked logo.

LOGO MINIMUM SIZE

To ensure legibility on print and digital media, adhere to the minimum logo size for each format.

MINIMUM CLEAR SPACE

To ensure clarity of the Recycle Right logo, we recommend setting a clear space around it. The general guideline is that the clear space should be at least half the height at which the Recycle Right identifier icon is displayed.





PLACEMENT WITH ORGANISATION/PARTNER LOGOS

"An initiative by National Environment Agency" must be used together with the Recycle Right logo on advertisements or collaterals by external partners where the NEA logo does not appear – to reinforce the association of the campaign with NEA. Placement of the additional line on the logo should not deviate from the examples shown here.



INCORRECT USAGE

Always use the artwork and lock-ups provided. The composition, colour and orientation of the Recycle Right logo should never be altered. Here are some examples of misuse:





Do not apply any effects or outline to the logo.



Do not use non-brand colours on the logo.



Do not modify the structure of the logo or translate it into another language.





Do not distort, skew or rotate the logo.





Do not substitute or modify the typeface of the logo.





Do not use any elements of the logo in isolation.



Do not apply the logo on a busy background.





Do not apply the logo on a dark or similarly shaded background.
